Dear Mr. Borden,

Body cameras were considered in the FY 2015-16 budget hearings. During that time Staff brought forward options for the City Council's consideration, but they were not approved due to lack of information related to ongoing maintenance cost. Staff advice the Finance Committee that the cost for the body cameras and the supporting maintenance cost associated with the cameras would come down as technology continued to expand in the market. It was the Finance Committee's remediation to continue researching body cameras and bring a comprehensive proposal forward including in car license plate readers and stationary license plate readers to the Finance Committee for consideration as part of the FY 2016-18 budget.
