Membership:

• Communication/Website:

- As always, input/suggestions for keeping the Website up to date are welcome.

• Outreach:

- The committee will submit an informational Outreach article for the Website.
- It was suggested that a "Webinar" replace our past in-person Open Houses throughout the County.
- o Grand Jury diversity remains a concern and will continue to be addressed at committee meetings.

Training:

- Ron and Max Thelen reported that the training, lasting 5 days, proved unique via Zoom, and was combined with the State's training. The State issued training binders and additional information.
