## Congratulations To Marin's 2023-24 Civil Grand Jury

This hardworking jury released 11 reports, including important follow-ups on government responses to previous reports and recommendations issued by our 2022-23 civil grand jury.

Topics covered by the 2023-24 jury ranged from sea level rise, to services for seniors, county detention facilities, spending controls, cyber security, E-bike safety, special education counseling, school supplies, and public spending on preserving Marin's agricultural lands.

These reports were publicized by Marin's Independent Journal in front page articles with numerous mentions in follow-up stories and opinion pieces.

"The 2023-24 jury produced high-quality reports on relevant topics with sound recommendations that should lead to lasting improvements in our local governments," said Spencer Sias, President, Marin Charpter, CGJA. "Our chapter is proud to have helped to recruit, select, and train this jury."
